SHORT TENDER NOTICE

The Cotton Corporation of India Ltd., Adilabad invites Sealed Tenders in Two Bid System (Technical Bid-I and Financial Bid-II) from reputed transporters for Transportation of F.P.Cotton Bales from various centers to various godowns for storage purpose for the cotton season 2017-18.

Tenderer should submit the tender as under:

1. Envelope "A" : Envelope marked as "Technical Bid-" which should contain all enclosures (as mentioned in terms & conditions), EMD and D.D of Rs.112/-
2. Envelope "B": Envelope marked as "Financial Bid" which should contain Financial Bid only
3. Envelope "C" : It should contain both Envelope –A & Envelope-B.

Each envelope should be superscribed as "TENDER FOR TRANSPORTATION OF BALES FOR THE COTTON SEASON 2017-18" and should contain the name and address of the tenderer at the bottom.

The Tender form duly completed in all respects along with EMD of Rs.5,00,000/- for transportation of bales addressed to the Branch Manager, should reach to the above address on or before 19.01.2018 upto 3.00 p.m. and the same will be opened at 3.30 p.m. on the same day, in the presence of tenderers who may wish to remain present.

EMD is not required from those who are having Bank Guarantee of Rs.8,00,000/- with CCI and transporters who have participated in the earlier tender and having their EMD of Rs.5.00 lacs lying with CCI.

The prescribed Tender Forms along with terms & conditions can be obtained from the Branch Office, Adilabad during working hours on any working day, on payment of Rs.112/- (Rupees One hundred twelve only including GST) by way of DD/Pay Order upto 2.30 p.m on 19.01.2018 and the same is also available at CCI's website <http://www.cotcorp.gov.in> and government tender portal <http://www.eprocure.gov.in> Downloaded tenders should be accompanied with Rs.112/- D.D/Pay Order of Rs.112/- in favour of "The Cotton Corporation of India Ltd" payable at Adilabad should be enclosed along with the tender. The Corporation reserves its right to accept or reject partly or fully any or all tenders without assigning any reasons thereof.

TERMS & CONDITIONS FOR TRANSPORTATION OF BALES

Sealed Tenders should reach to this office on or before 19.01.2018 up to 3.00 p.m. The tenders will be opened on the same day at 3.30 p.m. in the presence of the Transporters / Tenderers who remain present at that time. The terms & conditions of the Tender are as under: -

1. Tenderer should submit the tender as under:

Envelope "A" : Envelope marked as "Technical Bid-" which should contain all enclosures (as mentioned in terms & conditions), EMD and D.D of Rs.112/-

Envelope "B": Envelope marked as "Financial Bid" which should contain Financial Bid only

Envelope "C" : It should contain both Envelope -A & Envelope-B.

Each envelope should be superscribed as "TENDER FOR TRANSPORTATION OF BALES FOR THE COTTON SEASON 2017-18" and should contain the name and address of the tenderer at the bottom. Incomplete Tender forms and tender forms received after the stipulated time and date shall be rejected.

01. Technical Bid (BID-I) should contain seal & signed copy of Technical Bid, Terms & conditions and all enclosures as mentioned therein. Financial Bid (BID-II) should contain Financial Bid only.
02. First Bid-I of tender shall be opened, and if found correct in all respects Bid-II of the tender shall be opened. In case, Bid-I of the tender is found incomplete or without EMD the whole tender of the tenderer shall be rejected.
03. The rates should be quoted per bale basis separately for each destination **including Loading / unloading charges, Taxes and Levis if any** but excluding GST. The transportation rates will be valid **upto 30.09.2018**. The Corporation shall not be liable for any increase in rates either by Truck Unions or increase in rates of petrol, diesel, excise etc or for any taxes imposed either by Central Government, State Government or Local Authorities or otherwise.
04. The Transporter should take care of the bales during loading, unloading and transportation. The trucks should not contain any chemical/coal/sand contents etc. The trucks should be cleaned properly before bales are loaded. The bales in the truck shall be fully covered by tarpaulins to ensure full safety of the cotton bales. Losses of any kind during loading, unloading and transit shall be on the part of the Transporter.
05. The transporters shall deposit EMD of 5,00,000/- by Demand Draft drawn on any nationalized bank in favour of The Cotton Corporation of India Ltd., payable at Adilabad. EMD is not required from transporters those who are in CCI panel and are having bank guarantee of Rs.8,00,000/- with CCI and the transporters who have participated in the earlier tender and having their EMD of Rs. 5.00 lacs lying with CCI.

06. In case the L-1 tenderer does not carry the work or the work being done by L-1 Tenderer is unsatisfactory, the Corporation can allot the work to L-2 tenderer, if L-2 tenderer agrees at the rate of L-1 Tenderer. If L-2 tenderer do not agree at the rate of L-1 tenderer, the Corporation will make the work done by any other transporter finalized by laid down procedure and any loss incurred will be recovered from L-1 tenderer.
07. No escalation in rates will be considered on any account during the contract period.
08. Tenders received without EMD will not be considered.
09. Tenderers will be responsible for compliance of all statutory enactments and Corporation will not be liable on any account in this regard.
10. Corporation is not bound to award any minimum work. Work allotted at particular centre will have to be performed as per requirements.
11. In case goods under transportation are stolen or damaged during transit the transporter will be liable to make good of the loss.
12. The transporter will submit their bill supported with copy of L.R./transfer slip duly acknowledged, signed by CCI official certifying the receipt of bales in good condition. The bills of the transporter will ordinarily be paid within 15 days from the date of receipt of the bill in the branch office or within 15 days from the date of rectification of bills, in case of any discrepancy in the bill. The Tax would be deducted from the bills as per the Rules applicable from time to time. 10% amount from each bill will be retained towards Security Deposit, which will be paid after satisfactory completion of work and after completion of the season.
13. No over loading of bales will be allowed.
14. No detention/return charges will be paid.
15. In case of any accident or any incident, the transporter shall not remove the truck salvage from the place of accident or incident without preliminary survey and shall procure all the necessary certificates including copy of FIR/Non delivery certificate etc and shall inform the same immediately to the Branch Office. Transporter shall ensure the proper security and safety of the salvage till its disposal.
16. The concerned field officer shall be contacted to get the requirement of vehicles on day- to-day basis. Transporters are also liable for lifting of bales from factories within 24 hours. Hence, they should be in touch with centres/factories-in-charge on daily basis.
17. Bales of more than two different lots should not be mixed in a single truck.
18. In case of any loss or damage, the transporter will be bound to produce certificate as may be required by the Corporation and shall be responsible for any loss suffered by the Corporation in this regard.
19. Proper safety of the bales in transit should be ensured and for any transit loss, transporter only shall be responsible. If any transit loss incurred shall be deducted proportionately from Security Deposit or any unpaid bills. Trans-shipment is not permitted.

20. If the bales are not lifted within the prescribed time, a penalty of Rs.2/- per bale, per day shall be levied. It shall be enhanced by Rs.3/- after every two days maximum up to 3 days. In case the bales are not lifted even during this penalty period the Corporation shall be at liberty to get the bales transported at market rate by engaging other transporter and recover the difference, if any, from the default transporter. The Corporation's decision in this regard shall be final.
21. The Corporation reserves its right to accept or reject partly or fully any or all the tenders without assigning any reason thereof.
22. Copy of this terms and condition shall be submitted along with tender duly sealed and signed by the authorized signatory.
23. In case of any dispute of difference of claim arising out of or in relation to transportation of bales the same will be subject to Jurisdiction of Courts of Adilabad only.
24. In case of any legal dispute, the matter shall be referred to the Arbitrator (who shall not be an employee of the Corporation) appointed by the Branch Manager. The Arbitration will be conducted under the provisions of the Arbitration and Reconciliation Act, 1996 and decision of the Arbitrator shall be final and binding upon the parties.
25. The transporters whose rates have been accepted by the Corporation, will have to enter into a transportation agreement on a stamp paper of Rs.100/- and they will inform the name of their authorized signatory. The work will be allotted to the transporter only after execution of transportation agreement by them.
26. PERMANENT ACCOUNT NUMBER (PAN NO.) should be in the name of the Transport Company, otherwise Income Tax @ 20% will be deducted.
27. Tenderer should submit PAN certificate and also submit a copy of GST Registration certificate.
28. Rates quoted should be exclusive of GST.

The above terms and conditions are in addition to the normal liability of transportation for carrying goods and in case of any breach and/or non-fulfillment of above terms and conditions. The appointment of the transporter may be subject to cancellation at the option of the Corporation and it can make alternative arrangement for transportation of bales and in the process, if the Corporation suffers any loss or damage, the same will be on account of the transporter and shall be recovered by suitable means.
