5000 bales and above	90 days	90 days Branch wise equal lifting i.e. 50 % of sale quantity to be lifted in first 45 days and balance 50% in next 45 days

## **Terms & Conditions**

1. The above discount scheme will be applicable for purchase of cotton pertaining to any crop year for the **sales made from 01.08.2020 till 15.08.2020.**
2. The Buyers will be eligible for discount on bulk purchase as per the quantity of bales categorized above under Bulk Quantity discount scheme.
3. Quantity limit for cotton season 2019-20 (excluding KVIC/ Government mills) –  
  
The above discount will be considered for the quantity purchased on a particular day, irrespective of stock of any cotton season, subject to a maximum ceiling of 15000 bales for cotton season 2019-20.
4. The above discount scheme is applicable on CCI processed stock.

5. For availing the benefits under above scheme, MSME/KVIC/Co-operative spinning mills have to submit a certificate regarding self consumption of bales in the prescribed format as under:
